Important Information For the Upcoming Elections

With the State Primary Election set for September 8, 2020 just about a month from now, we wanted to provide our readers with information regarding the voting process.

We spoke with Erica Anthony, Pittsfield Town Clerk and she advised, "Covid 19" is now a valid reason to obtain an absentee ballot. Everyone should feel they can receive an absentee ballot if they're not comfortable coming in person to a polling location."

You can apply for an absentee ballot either through the Town of Pittsfield website <u>www.pittsfieldnh.gov</u> or you can pick one up at Town Hall; or phone The Town Clerk's office at 435-6773 extension 15 or email <u>eanthony@pittsfieldnh.gov</u> and one will be mailed to you.

One application may be used for both the September 8th State Primary Election and the November 3rd General Election. The General Election ballots will not be sent to you until after the results of the State Primary Election on September 8th have been recorded.

Town Hall must receive your completed ballot before the polls close on September 8 and November 3. You can either send your completed ballot via US Mail to Pittsfield Town Clerk, Pittsfield Town Hall, 85 Main Street, Pittsfield, NH 03263. Alternatively you can hand deliver your ballot to either Erica Anthony, Town Clerk or Yvonne MacGlashing, Deputy Town Clerk. Please do not leave your completed ballot in the drop box, either Erica or Yvonne must receive it in person. Once you turn in your completed ballot, you can track the status on the New Hampshire Secretary of State website <u>www.app.sos.nh.gov</u>

For both the State Primary Election and the General Elections if you choose to vote in person, wearing a face mask is strongly recommended and social distancing will be in place. As we approach both the State Primary and General Elections, additional information will be available on the town website, Town Clerk/Tax Collector Facebook pages and here in *The Pittsfield Post*.

Select Board Review July 28, 2020

Scott Lacroix, Code Compliance Officer was in to sign his contract. He'll be working up to 20 hours/week as building inspector, zoning administrator and code compliance officer. He has hours by appointment (call 715-6624) at the Town Hall Mondays 1-7pm and Wednesdays. 7am -1pm.

Pittsfield taxpayers have really stepped up despite Covid19 challenges, with tax revenue coming in on time at least as punctual as a "normal" year. The select board truly appreciates being able to meet our financial obligations without having to borrow money in anticipation of what "might" be collected.

Budget season is already upon us, so the Capital Improvement Plan, Budget Committee and Select Board must ramp up meetings and hearings in order to meet SB2 deadlines.

Parks & Recreation, Pittsfield Youth Workshop and the Library have requested moving four picnic tables being underused at the pool to Dustin Park where PYW, the Library and the public can use them. We approved, subject to the trash being policed by volunteers and CDC "clean-up" guidelines being posted at the tables. We hope this "first come, first served" use of town property will be successful.

Two public hearings are scheduled for the select board meeting August 11. First will be public input regarding a donation to the town in excess of \$10,000 (required by state law). The second hearing will be to hear public input regarding a proposed Health Ordinance. Based in large part on that public input, the Board may move forward with placing the proposed ordinance on the ballot next March to ultimately be decided by the voters. *Carl Anderson*

Cook's Corner Tomato and Onion Pie Oh My!

Have you seen those gorgeous tomatoes at the farmers' markets? Or are you

wondering what you're going to do with the bumper crop of tomatoes growing in your backyard? Well here's an easy and very tasty idea that will definitely bring smiles around your table.

1 cup fresh, fine bread crumbs or Panko

3 cups sliced tomatoes, preferably large beefsteak variety

1/2 to 1 cup thinly sliced onion, preferably Vidalia

2 cups shredded Cheddar cheese

2 large eggs, lightly beaten

Salt & pepper

3 to 4 strips of bacon, halved crosswise

(or ¼ cup of precooked bacon crumbles and ¼ cup sliced scallions)

Heat oven to 325F and butter a 9 inch glass or ceramic baking dish or deep dish pie plate.

Sprinkle ½ cup bread crumbs evenly on the bottom of the baking dish. Arrange half of the tomatoes on top of the bread crumbs, sprinkle with a little salt & pepper. Then layer half of the onion slices on top of the tomatoes. Sprinkle half of the cheese on top of the onions. Then repeat the same layering process. Pour the eggs over the whole pie.

You can top the pie with the sliced bacon in a lattice work design and bake the pie in the middle rack of the oven for about 45 minutes or until the bacon is crisp. Or you can omit the bacon and when the pie comes out of the oven top the pie with bacon crumbles and scallions.

What a fun Summer dish, especially now when fresh tomatoes are bountiful. This pie is great served alongside grilled chicken or fish or serve this with a big pan of scrambled eggs for a neat 'breakfast for dinner' date. Bon appetit! *MP Christakos*

IT'S IMPORTANT TO COMPLETE A CENSUS FOR ALL PROPERTIES, INCLUDING SEASONAL HOMES!



If you live at multiple places throughout the year, count yourself at the address where you live and sleep most of the time. If you split your time evenly between two or more places, count yourself where you were staying on April 1, 2020. However, a census response is required from each and every property.

For any property you own but only use part of the time, follow these instructions:

- 1. Visit <u>www.my2020census.gov</u>
- 2. Enter the Census ID or address for this secondary property
- 3. Enter "O" for the number of people living at this property
- 4. Hit Next, and when a "soft error" occurs, click Next again
- 5. Select "No" when asked to confirm no person lives at this property
- 6. Select primary reason Seasonal (most likely)
- 7. Complete! If you have already completed the 2020 Census for your primary

residence you can exit at this point.

Following these instructions ensures all properties are counted! For more information go to 2020census.gov or call 1-844-330-2020.
