

School Board Update

We have had busy agendas at our meetings as of late, and our meeting on December 1 was no exception. The Board heard from Mr. Wiley from PES about the many exciting happenings at the elementary school including a successful food drive and a recent Whole School Morning Meeting (WSMM) where students partnered to write letters of gratitude to soldiers and veterans. The Board next heard from Mr. Hamilton about the behavioral data at PMHS, the recent *I am College Bound, I Applied Campaign* and an update about the upcoming NEASC accreditation visit this March.

Both building level administrators discussed recent state testing data with the Board. Mr. Wiley shared the work of PES teachers and staff from their inservice work on Wednesday, November 16. The faculty and staff participated in a data dive into the previous three years of state testing data. From this information, teams created SMART goals (Specific, Measurable, Attainable, Relevant and Time-bound) to address specific needs and goals at each grade level. The Board is grateful to Mr. Hamilton for his thorough presentation of the data for PMHS. He contextualized the results and gave concrete short-term and long-term solutions to address the testing results.

While the Board posted amended language to the JBAB, Transgender and Gender Non-Conforming Students policy prior to the meeting, the Board agreed that both the public and the Board needed more time to review those changes prior to voting. A draft of these proposed changes is available, as a viewable Google Doc, on the link for our district policies.





To our constituents in Chichester and Pittsfield,

On December 7, we were sworn in as your State Representatives. This meeting was critical because the official count was 201-198 Republicans/Democrats with 1 tie - the tightest majority in the history of the NH House! We voted for Sherman Packard (R-Londonderry) as Speaker of the House (205-184 with some democratic votes). The Republicans now officially have majority control, with Jason Osborn (R-Auburn), as the majority leader, and Matt Wilham (D-Manchester), as the minority leader.

The next order of business required a joint session with the Senate to elect the Secretary of State and the State Treasurer. We voted to re-elect David Scanlan for Secretary of State, who won against Melanie Levesque, a former State Senator (237-175). Of special interest was Valerie McDonnell (R-Salem), who seconded the nomination. She is the youngest member of the NH House at 18! An honor that also gave her the call to lead the pledge at the beginning of the session. State Treasurer Monica Mezzapella was uncontested. The joint session was closed.

The last order of business dealt with the tie: Chuck Grassie (D-Rochester) and David Walker (R-Rochester) tied after the recount! We met with Secretary of State Scanlan the day before the session to understand the process. The House gets to decide! Some options are the House votes to break the tie or order a special election. A coin toss could also resolve it. A motion was made to pass HB 6, which would call a special election. After an attempt to table the bill failed by a roll call vote (votes recorded by representative), HB 6 passed by a simple voice vote (vote count not known). These items were the important business of the day. Believe it or not, our total time as a Representative went from 8:00am - 8:00pm, with our time at the House being a 7-hour first day! 
Filled with zany STEAM traps, a silly story, and fun illustrations, this hilarious picture book is a perfect holiday story for parents, educators, and kids of all ages!



Cook's Corner

Boursin Mashed Potatoes & Herbed Crescent Roll Pinwheels

I'm sure you have your main dish in mind for Christmas dinner, but in case you're looking for some different sides, here are two that are sure to please. These mashed potatoes with Boursin cheese are absolutely divine! And the herbed crescent rolls are amazing. I know you will love these, they're both elegant additions to your table. Enjoy! MP Christakos

Boursin Mashed Potatoes

- 1 & ½ lbs russet potatoes
- 1 & ½ lbs Yukon gold potatoes
- 1 cup whole milk
- 4 TBSP butter, cut into pieces
- 2 (2.5 oz) packages Boursin garlic & herb cheese, divided

2 large eggs

Heat oven to 425. Peel and cut potatoes into 2-inch chunks. To a large pot, add potatoes, salt and enough cold water to cover potatoes by 2 inches. Partially cover the potatoes and heat to a boil over medium heat. Reduce heat and simmer for 15 minutes, until potatoes are very tender. Drain potatoes well and return to pot.

To a microwave-safe bowl, add milk, butter and ½ tsp salt. Microwave for 1 to 2 minutes, until milk is simmering and butter is melted. Add milk mixture to the potatoes and mash with a potato masher until smooth. If making this ahead of time, refrigerate the potatoes and wait to complete final steps until the next day.



In a medium bowl, whisk 1 Boursin cheese until fuffy, gradually adding 1egg at a time to fully combine (adding both eggs). Add the cheese mixture to the potatoes and stir well to incorporate. Season with salt & pepper. Transfer mixture to a lightly greased 2 quart baking casserole. Place the remaining Boursin cheese in the center of the dish. Bake for 30 minutes until fluffy and warmed throughout.

Herbed Crescent Roll Pinwheels

- 1/4 cup fresh parsley, chopped
- 2 TBSP fresh rosemary, chopped
- 2 TBSP fresh oregano, chopped
- 6 TBSP butter, softened
- 1 tsp garlic, minced
- 1 (8oz) tube refrigerated crescent rolls

Heat oven to 400. Chop the parsley, rosemary and oregano (or use a mini-chop machine). In a small bowl, mix the softened butter, herbs and garlic. Season with salt & pepper.

On a large sheet of parchment paper, unroll the crescent roll dough, firmly pressing on the perforations to create 1 large sheet of dough. Spread the herb mixture over the dough. Starting from the short side of the dough, roll up jelly-roll style. Using a serrated knife, cut the dough into ½ inch thick pieces. If dough is too soft to slice, place in the fridge for 30 minutes until firm.

Arrange the slices on a parchment paper lined rimmed baking sheet and bake for 15 minutes, until golden brown.

You can double the herbed butter mixture if you like and serve it on the side.


