To my constituents in Pittsfield: From Carol McGuire

This week, the House met to consider all 2019 bills remaining. Most were killed; we passed (on a party line basis) some repeats that will get the same result as last year (killed in the Senate or vetoed by governor): minimum wage increase, the an independent redistricting commission, mandatory family leave, green energy subsidies, bans on plastic shopping bags. However, we also debated and passed a number of bills that won't hit the headlines. HB 721, restricting town tuitioning to schools that have an "approved" special ed programming, passed 214-152. SB7. allowing voter registration at the DMV. 203-163. despite and passed the costs inconveniences. HB 311, allowing the state fire marshal to waive some fire code requirements for sober living facilities, passed 269-92. SB 34, defining "attempt to drive" for DWI purposes, was debated at length, with supporters urging us not to convict people for what they might do. A motion to kill the bill failed, 158-184, and it passed on a voice vote.

I spoke against two bills from my committee: HB 221, renaming Columbus Day to Indigenous People's Day, which was tabled on a 179-178 vote; and HB 546, creating a license requirement for art therapists. After a brief debate, it passed, 218-144, with 6 Republicans, including John Klose, joining all but 6 Democrats in favor.



Automotive Wastes: Pallet Lower Floor Lead Acid Batteries, Oil, Antifreeze

Cans - Aluminum: Upper Recycling Floor Clean Aluminum Beverage Cans Only

Cans - Tin: Upper Recycling Floor Clean Tin, vegetable cans, pet food cans & foil

Clean Dry Cardboard: Upper Recycling Floor Corrugated boxes. No wet, soiled, waxed, foiled or plastic-coated cardboard

Demolition - Fee Item: Check Fee Schedule Shingles, sheet rock, masonry, painted, treated or manufactured wood, wood over 5" etc.

Electronics - Fee Item: Lower Floor Computers, Monitors, TV's, All Electronics

> Glass: Upper Recycling Floor Glass bottles, ceramics, china


Metal: Box #5 Out Back All metal items except refrigerant units


