School Board Update

The School Board has been busy with the budget process as well as continuing work on our goals. At our last meeting on January 6th, we reviewed the warrant articles, heard from the building level administrators and reviewed policy (as part of our new biweekly policy review process). Upon the conclusion of the public meeting, the Board worked on a survey for all stakeholders about the superintendent search.

Community members are encouraged to weigh in on this survey which asks whether the town would like the Board to begin a search for a permanent part-time superintendent or offer a 1 year extension to our current interim part-time superintendent, Mr. Bryan Lane. This survey is available on the district's Facebook page and was also shared through school messenger with parents, faculty and staff. The survey will remain open until Wednesday, the 19th.

Community members are also encouraged to get informed about the school budget and related warrant articles. Mr. Lane gave an informative presentation last night at the Budget Committee Hearing explaining both the budget and the proposed teacher contract. Mr. Lane welcomes your questions and comments via email, phone call or visit to the SAU office.

To my constituents in Pittsfield,

This week, the House met to vote on all remaining 2021 bills. My committee had only one important bill: HB 275, finalizing the emergency powers reform we worked on last year. This bill limits the governor to three renewals (84 days) but allows the legislature to declare an emergency for 90 days, renewed as often as necessary; it was debated and passed, 190-1.

I spoke on the redistricting bills, HB 50, state representative districts, and HB 54, county commissioner districts. These, and the congressional districts, HB 52, all passed on largely party line votes. The Senate may make some tweaks, but I expect these districts to be adopted.

There was a rare (first time I've seen one!) unanimous vote on HB 549, restructuring the system's benefit charge for energy efficiency projects. After a Democrat amendment failed, both sides urged us to pass the bill!

The local education freedom account, HB 607, was tabled, 187-170. It may return this year, but obviously the House is split on the issue.

Select Board Review- January 11, 2022

Not a lot of excitement in the past couple of select board meetings. Most of the public seems to be staying pretty close to the hearth rather than venture out on cold winter nights to observe our meetings. Just a reminder, meeting minutes are available on the town website so it's possible to keep up from the luxury of home.


The bulk of the business conducted during the past two meetings has consisted of budget reviews and preparations for the 2022 Town Warrant. Election day is March 8 and will be here before you know it. The ballot itself will be shorter than usual, there being no proposed zoning amendments and no petition articles. There will, of course, be election of officers for expiring seats, as well as the money items.

The "deliberative session" of town meeting under SB2 will be Saturday February 2 at 10 AM and is the nearest we now get to our old (and by many missed) form of town meeting. It is basically a Q&A session regarding the ballot questions, and your opportunity to hear from the department heads relative to their needs and requests. It's informative, but lacks the voting component, which is done on the ballot itself on March 8. Hopefully many voters will turn out for the deliberative session so they can make their most informed decision at the ballot box. *Carl Anderson*, Selectman
