## Cook's Corner Potato & Leek Soup



St. Patrick's Day is upon us! I'm delighted to share another classic recipe from my great grand Mama, Katie Collins. I've updated this recipe a bit, adding

garlic and ideas for toppings, to meet our more modern tastes; but this soup is truly a good old fashioned tradition. Katie was a force of nature; raised 7 of her own children and 6 of her grandchildren. During Prohibition, she made her own beer in the cellar. Who would have thought the president of the Altar & Rosary Society of St. Mary's Church in Wilkes-Barre, PA was a bootlegger! I hope you enjoy this pot of lusciousness. "May the road rise to meet you; May the wind be always at your back; May the sun shine warm upon your face..." Slainte! *MP Christakos* 

3 TBSP butter

4 large leeks, white & light green parts only, washed thoroughly and roughly chopped

3 cloves garlic, peeled and smashed

2 lbs Yukon Gold potatoes, peeled and chopped into  $\ensuremath{^{\prime}\!_{2}}$  inch chunks

- 7 cups chicken or vegetable broth
- 2 bay leaves
- 3 sprigs of fresh thyme
- 1 tsp salt
- 1/4 tsp black pepper
- 1 cup heavy cream

Fresh chives, chopped, for serving

Melt butter over medium heat in a large stock pot. Add the leeks and garlic, cook, stirring often, until soft and wilted, about 10 minutes, but do not brown.

Add potatoes, broth, bay leaves, thyme sprigs, salt & pepper to the pot. Bring to a boil. Cover, turn heat down to low. Simmer for 15 minutes or until potatoes are very soft. Fish out the thyme sprigs (discard). Let the soup cool for about 10 minutes.

Working in batches, transfer the soup to a blender. Remove the cap at the top of the blender lid, cover with a dish towel and puree the soup, until smooth. Return the soup to the pot. Add the heavy cream and stir well. Taste and re-season with salt & pepper, if necessary.

Serve the soup topped with chopped chives, garlic croutons and a little shaved Parmesan cheese. Oh ... put the pepper grinder out too. - *MP Christakos*

#### HOW SWEET IT IS ....

These past few weeks, I have had the pleasure of being with a group of friends that were boiling sap....to make a most delicious maple syrup. Pittsfield native, Billy Carpenter, has been doing this for many years, at his sugar shack in Barnstead, NH and I have learned so much from him about the production of this sweet treat!

#### Here are some facts that you may or may not know:

-One maple tree can produce up to 15 gallons of sap per year.

-It takes about 40 gallons of sap to make 1 gallon of syrup.

-A wood-fired evaporator is used to boil away (or evaporate) water from the sap until it reaches <u>219</u> degrees on a Bi-metal thermometer.

-Maple syrup contains more calcium than the same amount of milk.

-Maple syrup is an excellent source of potassium, magnesium, phosphorous, zinc and iron.

-Sugar sand, or niter, is a naturally occurring substance which forms as the maple sap is boiled. It is an edible component of the syrup. Filtering removes the niter, leaving a clear, golden product.

The next time you pour this treasure onto your pancakes, waffles or French toast...savor it most fully!

## Maple-Pecan Cake

1box yellow cake mix

2/3 Cup of water

1/3 Cup butter, softened

3 eggs

1/2 Cup maple syrup

 $\frac{1}{2}$  Cup chopped pecans, toasted

#### **Cream Cheese Frosting**

1½ Cup powdered sugar

3 Tablespoon butter, softened

1½ oz. cream cheese, softened

3-4 Tablespoon maple syrup

Oven: 350°F (325°F for dark or nonstick pan). Generously grease & lightly flour 12-cup fluted bundt cake pan

Beat cake ingredients on low 30 seconds, then on medium 2 minutes, scraping bowl occasionally. Pour into pan.

Bake 47-53 minutes or until toothpick inserted in center comes out clean. Cool 10 minutes; remove from pan to cooling rack. Cool completely, about 2 hours.

Beat powdered sugar, butter, cream cheese and syrup on low. Beat in enough of the remaining syrup to make a smooth, soft frosting that will flow down side of cake. Spread frosting over cake. Store loosely covered in refrigerator.

**TIPS**:-Instead of the frosting recipe, mix pre-made cream cheese frosting w/ 4-5T maple syrup or just drizzle w/maple syrup.

-To toast the pecans: spread in shallow ungreased pan; bake @ 350°F, 6-10 minutes, stirring occasionally, until light brown.



HB1623 passed 184-168 and revised the state energy policy to promote affordable, reliable, and secure energy resources for NH citizens while reducing the risks of power outages in our great state, otherwise known as "brownouts."

HB1118 passed 179-166, providing requirements for issuing nonresident alien driver's licenses. Such licenses will expire when a non-resident's visa or other expires.

The House was back in session on March 7, starting at 9:00, with 54 bills on the docket for discussion. The session ended at 6:00 pm, and the last 10 bills were moved to the following week.

Some of the bills that were discussed included:

CACR17 was a constitutional amendment giving parents the fundamental right to direct their minor child's upbringing, education, and care, which should not be infringed upon. This bill failed (180 – 183), lacking the necessary 3/5 votes.

HB1263 authorizing the use of parenting coordinators in high-conflict family court cases, setting qualifications and requirements, passed unanimously by voice vote.

HB1266 permitting audio and video recordings in the family court passed 191-173.

HB1308 failed (170-194) and would have allowed parents or legal guardians access to their minor child's library records. We wonder why the anti-parenting caucus wants this information kept secret from parents!!!

HB1527 failed (161-202) to allow owners to mark their property against trespass with purple paint markings, establishing criminal penalties and prohibiting removal of the paint markings. Currently, signs are posted with the ability to prohibit specific activity and identify the property owner. The representatives felt that the current method follows the spirit of sharing land in our great state.

HB1437 failed (173-193) to provide for an 11-member state board of education staffed by professional educators and administrators. The opponents of this bill presented arguments that professionals should not be tasked with regulating themselves based on best practices and state court rulings against such a structure.

CACR14 was a constitutional amendment to provide and maintain a clean and healthy environment for present and future generations, but it failed (168-197.) This bill was a copy of a bill that passed in Colorado that has been plagued with litigation.

HB1240 was tabled 310 - 54, adding eating disorders as a qualifying medical condition for therapeutic cannabis.

HB1213, which removed the immunization requirements for childcare agencies, passed (189-173). This requirement would be a financial burden for small agencies.

HB1660 passed (193 - 169) and removed the state Medicaid plan from providing gender reassignment treatment for minors. Recently, the House passed legislation making it illegal to do gender reassignment surgery on minors.

HB1037 failed 163-196 to repeal limited liability for manufacturers, distributors, dealers, or importers of firearms and ammunition.
