To The Editor:

Last week I wrote to the Post about my experience after offering to fill a vacant School Board position.

Another Pittsfield resident and I each offered to be considered for a single interim appointment to a vacant Board seat.

We went through the process required by the School Board and finally learned that its four members were divided, dead-locked in voting, and unable to make a decision.

The Board, acting on advice provided by the Superintendent decided to leave the vacant position unfilled until next March and then 'let the voters decide.'

In my letter last week I condemned the School Board for failing to fill the vacancy as required by State law and requested that the school District's business, and the expenditure of the \$10 million annual budget be conducted by a full five member board.

Today I met with the School Board to discuss the necessity of having a full Board in place to conduct the School District's obligation to the community, its students, and the taxpayers.

I wasn't there alone. I was there with Louie Houle who had also offered to be appointed to the vacant position.

The first part of the meeting was devoted to a condemnation from a Board member who told me that she thought that I was 'rude' to have described the Board as 'dysfunctional' in an email.

Then the Board got into the business of how to fill the vacancy. A motion to appoint Louie Houle failed as before on a 2-2 deadlock.

I suggested that the Board spin a coin and see how it landed, or pull names from a hat. This was rejected as unacceptable to a Board member. The statutory remedy of having the town Select Board fill the vacancy was also rejected. It was once again a divided Board, the voting split 2-2 and no decision. I still call this dysfunctional.

At that time I asked Louie if he would agree to getting past this nonsense by us two flipping a coin, with the loser withdrawing from consideration. He agreed.

And then it got to be fun because no one had any money. Not me, not Louie, nor Adam the Chairman. No point in asking the member who wouldn't descend to coin flipping; and that left just one member who clearly could not be expected to be the one who might make it all happen.

What happened was that Diana Westgate, sitting further back, offered a quarter coin. I told Louie that I, lacking a thumb, would call if he would spin.

We did all that and Louie Houle won the toss.

I withdrew from being someone who would get appointed. Diana got her money back. And I have no regrets about not needing to go to School Board meetings. Bill Miskoe

To my constituents in Pittsfield,

This week, the House met in committees of conference. I served on two: SB 358, which was completely rewritten to revise the administrative rules process, and SB 313, where we added a new oversight committee for the office of professional licensure, and made a number of other changes clarifying their fee authority. The committee on SB 313 met briefly, and agreed on all the House changes; we also restored a section on the board of medical technicians, which had been deleted in anticipation of repealing the board (HB 1330, doing so, passed the House and was killed in the Senate.)

The committee on SB 358 stalemated because the administrative rules staff showed up (for the first time since I proposed the amendment) and brought up some difficulties. After that, the Senators refused to accept any changes.

At the meeting of the joint legislative committee on administrative rules, we objected to the update to the passenger tramway safety rules, since they were apparently creating a license for the lift inspectors. Our laws require explicit statutory authority to require a license, but this board has been operating since before there were such restrictions and just kept on going the way they had been... We also approved, by a partisan vote, the "Learn Everywhere" rules, which require high schools to grant credit for programs approved by the state board of education, as well as the local board. Last session, with a Democrat majority, we had objected to the rules – but they have never been challenged in court.

Cook's Corner Shrimp Boil



Many of us anticipate Memorial Day Weekend as the kick-off to Summer. The day however has solemn roots that date back to just after the Civil War and for several decades it was known as Decoration Day. It wasn't until 1968 that the US Congress passed a law creating what we now know as Memorial Day.

Meanwhile, I'm sure most of us are looking forward to the kick-off of summertime; and here's a recipe that fits the bill. This version serves 4 to 6 people, and it's easy to double if you have a larger group. Great sides to round out this meal are cornbread muffins (use the Jiffy brand mix), cole slaw (homemade or keep it easy with store made),

and thick slices of juicy tomatoes. Add your favorite ice-cold craft beer, extra napkins, music, a little dancing and you just boiled up a party! MP Cristakos

3+ quarts of water

14 cup Old Bay seasoning

3 to 4 TBSP lemon juice

1 lb baby potatoes (red or yellow)

1 lb <u>raw</u> shrimp, unpeeled

1 lb andouille or chicken sausage links, cut into 1 inch pieces

2 to 3 ears of corn, husked and cut in half (or 4 to 6 small ears of frozen corn)

1 large leek, washed & sliced, keep both green & white parts

Lemon wedges for serving

Melted butter for serving

Combine water, Old Bay and lemon juice in a large stock pot. Bring to a boil. You can do this on your stove top, or on your grill top. Once it boils, add potatoes and cook until almost tender, about 10 to 15 minutes.

Add shrimp, sausage, corn and leek; cook, stirring often until the shrimp are pink and the veges are crisp tender, about 5 to 6 minutes.

Using a slotted spoon and tongs, divide the mixture among 4 serving bowls. Drizzle each bowl with some of the cooking liquid. Serve with melted butter and lemon slices.




