Church Hosts Kristjon Imperio in Concert

The First Congregational Church, 24 Main Street, Pittsfield, is pleased to host Kristjon E. Imperio in an organ and piano concert Friday, November 11, 7 p.m. Kristjon currently serves as organist and assistant director of music at the Wellesley Village Church, Wellesley, MA. He is also an administrator at Pakachoag Music School, Worcester. Kristjon has performed as a soloist and conducted performances throughout New England. Also featured will be vocalists Abigail Small Borchelt, soprano, and her father, Steven A. Small, baritone.

Kristjon will be playing the church's 1877 Wilson W. Ricker Company (Boston) tracker organ. It is the only one manufactured by that company known to exist today. The case is solid black walnut and it has two manual keyboards and a pedalboard. Air into bellows was originally pumped by hand, later by electricity. The organ went through a major rebuilding in 1965 and boasts 564 pipes.

The program will contain a variety of music and will offer a salute to veterans. Please plan to attend this free, fascinating and unique musical experience. Parking and a wheelchair accessible entrance are available at rear of the church. For more information, call the church office, 603 435-7471.

Cook's Corner

Creamy Chicken Taco Soup Slow Cooker

Now that it's officially soup season, we'll focus the next few issues on



recipes for tasty pots of goodness. Kicking off the mini-series is this Creamy Chicken Taco Soup. It's a great slow cooker idea, super easy to put together and uses healthy and affordable ingredients. In terms of heat-level, this one is very tame; but you can amp up the heat index by adding more chili powder or even a dash or three of hot sauce. I typically serve this hearty soup with a few toppings such as shredded Cheddar cheese, jalapeno slices and tortilla chips. Put out some cornbread and a nice cool salad and dinner is done. This soup keeps well in the fridge and it's even better the next day, when all the flavors bloom. Enjoy.

3 & 1/2 hour cook time

Cooking spray

1 cup diced onion

1 cup diced green bell pepper

1 cup diced red bell pepper

10 oz frozen corn, thawed in the microwave

1 tsp salt

2 cups chicken broth

1 (10oz) can Rotel (tomatoes & green chilis)

1 (10 oz) can Cream of Mushroom Soup

1 (4 oz) can chopped green chilis

2 TBSP vegetable or olive oil

1 TBSP taco seasoning (from an envelope packet)

1 TBSP ground cumin

1 TBSP chili powder (or more if desired)

14 tsp ground black pepper

2 lbs boneless chicken breast (about 2 large breasts)

1 (10 oz) can black beans, drained

1 (8 oz) package of cream cheese, cut into chunks

Toppings: shredded Cheddar, jalapeno peppers, tortilla chips

Spray the slow cooker bowl lightly with cooking spray. Add onion, bell peppers, corn and 1 tsp of salt. Stir well to combine. Add the chicken broth, Rotel, Cream of Mushroom soup and the green chilis. Stir again to combine.

In a separate, shallow bowl, combine oil, taco seasoning, cumin, chili powder and black pepper. Stir well until a good paste forms.

Add the chicken breasts to the paste and schmear both sides of each chicken breast with the paste. Transfer the chicken to the slow cooker, nestle them into the sauce and spoon some sauce over the chicken. Cook on LOW for 3 hours.

Remove the two chicken breasts, let cool slightly, then carefully shred the meat with two forks. Return the meat to the slow cooker bowl. Add the drained black beans and the cream cheese chunks, stir well until smooth and the cream cheese has melted. Put the slow cooker back on LOW and heat for another 30 minutes. Bon Appetit!

Do you support the state's current system of public school funding, with each district's total funding primarily dependent on local property tax revenue? Yes. The system is far from perfect but many other alternatives have been discussed and they all rely on more broad based taxes which I am firmly opposed to as it would be an economic disaster for New Hampshire. We should continually pursue expanding school choice opportunities for families.

Do you support the "Education Freedom Account" program, which gives students access to the per-pupil share of state school funding to spend on private school or home school expenses? Yes. Parents should be able to access the funds that come out of their own pocket for education for what they believe is the best way to educate their child. The state should be striving to expand parental rights in education as much as possible, not remove parental rights, as has been attempted by the federal government bureaucrats in Washington.

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)? I support New Hampshire's current law which bans the abhorrent practice of late term abortions. I will review other legislation when and if it is proposed.

Should NH pass stricter gun control laws? No, I will always defend and support our Second Amendment right to keep and bear arms.

Should the New Hampshire government do more to address climate change? No. Climate change alarmists and activists are using their crusade to drive up the cost of energy and electricity which is at an all-time high. Granite Staters are starting to lock in their home heating oil rates for the winter and many cannot afford the outrageous prices. We need to reduce the cost of energy not give in to climate change alarmists

I'm running for New Hampshire State Senate District 17 because I believe in a strong economy, fair taxes, quality education, gun safety, and the right of individuals to make their own health and reproductive choices. Do you support the state's current system of public school funding, with each district's total funding primarily dependent on local property tax revenue? Our kids — all of them — require a quality education to help our families and state thrive. The current public school funding system isn't designed to meet this need. The education of New Hampshire's children should be shared in a more balanced way between local communities and the state. I've viewed this issue from many lenses: as a parent, teacher, school board member, social worker and policy maker. The data shows us that when education is a priority, communities are healthier in every way, including economically. Investing in our kids is the smartest move we can make.

Do you support the "Education Freedom Account" program, which gives students access to the per-pupil share of state school funding to spend on private school or home school expenses? I don't support the Education Freedom Account (EFA) as written. I think school choice can be important for some students. I look forward to working across the aisle and local communities to better understand how this model can work most effectively. But EFA as expressed now is not a best use of state funding. It doesn't make sense, for example, to drain local public school budgets in order to subsidize students whose parents have already made the choice to send them to private religious schools.

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)?

Politicians are not doctors and women are not political footballs. The decision to terminate a pregnancy is in the sole purview of the pregnant person, her physician and other trusted counselors and loved ones. It is irresponsible and harmful for the uninformed to speculate on the unique conditions that lead to personal health care decisions. Abortion is health care. It must remain a private choice outside the realm of political debate. The measures that have been taken in the Granite State to judge, punish, restrict and control women signal a political will in the current climate that has the potential to snowball the erosion of all of our freedoms. This must not stand. We must instead stand up for the democracy upon which our country and state were founded.

Should NH pass stricter gun control laws?

While it is sometimes misunderstood by folks across the spectrum on this issue, the right to bear arms is not up for debate. I hunted with my dad when I was a youngster to put food on the table and there are many excellent marksmen and women in my family who enjoy the sport. No matter where you stand on gun use, I believe we can all agree on the root concern: gun violence and safety. I'll approach gun safety as a public health issue. Framed in this context, we can have the necessary conversations needed to determine how to promote successful gun violence prevention efforts and ensure gun safety through closing loopholes in purchasing, background checks and licensing.

Should New Hampshire government do more to address climate change?

We should absolutely be stepping up our efforts to address climate change, efforts that go hand in hand with lowering energy costs and addressing other essentials that affect our daily lives, including affordable housing and reliable energy grids. Granite Staters enjoy abundant and beautiful natural resources. As both a small business owner who knows the value of outdoor recreation opportunities and an avid hiker who loves to spend time in the woods, I'm deeply committed to protecting our natural resources. The Granite State is at the back of the pack when it comes to climate action. I'll work to get us up to speed — and make it possible for all of us to be able to afford to keep the lights on.



James C. Allard, NH House of Representatives Candidate, Republican



I am a write-in candidate for re-election to the General Court. I have served the past four years as a representative for Pittsfield and Epsom (Merrimack District 21). With the realignment of the House Districts, Pittsfield and Chichester will now form District 13. I have served on the Public Works and Highways Committee, Education Committee, and the Fish & Game Committee. Additionally, I am a member of the Veterans Caucus and the Congressional Sportsman's Caucus; and in my eighth year as a member of the Pittsfield Selectboard, six years as chairman. I am a New Hampshire native living in Pittsfield for the past 13 years, educated at UNH, Boston University, and SNHU. I served 31 years of active duty with the US Army and worked an additional seven years as a Department of the Army civilian, retiring in 2013. In other relevant experience I was a trustee of the Josiah Carpenter Library and served

42 months as a conservation commissioner for the town of Brunswick, Maine. I am especially proud of sponsoring and passing legislation to expand business opportunities for small farmers, creating a new on-line university in New Hampshire, and waiving tuition for the children of New Hampshire's 100 percent disabled veterans at our state colleges and universities. I hope to return to the State House in the coming term to continue this sort of work for the people of our new district.

Do you support the state's current system of public school funding, with each district's total funding primarily dependent on local property tax revenue?

I do not. Our state has been in contempt of court for more than twenty years due to its failure to comply with the court's order to establish a fair and equitable manner for distributing education funding. A system based solely on property taxes is inherently unfair. Districts with valuable property can afford to fund expansive educational programs. Property-poor districts such as ours struggle to provide an adequate education. Under the current system this will not change. Children who grow up in our small and rural communities, or the over-burdened urban districts, will always stand in the shadow of those who grow up in the affluent suburbs and towns—unless we make real change. No child in Colebrook or Chatham deserves less of an educational experience than those in Exeter, New London, or Hanover. We need to define the education we want for our children and pay for it equitably across all our school districts.

Do you support the "Education Freedom Account" program, which gives students access to the per-pupil share of state school funding to spend on a private school or home school expenses?

I vigorously oppose the EFA program in its current form. I do not support the taking of any <u>public</u> funds for <u>private</u> gain. We all are free to educate our children any way we might wish, but we are not free to make our neighbors subsidize our personal choices. Neither should we be using public funds to line the pockets of private institutions. As legislators, we should be devoting ourselves to doing the greatest good for the greatest number of citizens. The EFA program was sold as a low-cost opportunity that would affect a small number of students. In its first year, the program exceeded its budget ten-fold. The wholly private "administrator" of the program takes ten percent of the funds off the top, with no oversight. In the majority of NH's towns there is no access to private schools. Many of the existing private schools have no interest in taking EFA students. For others, the small individual amount allocated cannot possibly meet the actual cost of a student's private tuition. The EFA program is also not open to all. It uses tax dollars of all NH residents, but is a privilege open only to those who meet certain criteria. Apparently, it is education freedom for the few.

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)

In the previous session, the Legislature enacted certain abortion restrictions after the 24th week of gestation. This was a much debated, worked and compromised piece of legislation. Since that time the Governor, Speaker of the House, and the Majority Leader have each said that no further changes of NH's abortion statutes are needed at this time. I support that position. Having passed a subsequent bill to protect abortions beyond 24 weeks in cases of fetal viability and danger to the mother, no changes are needed now to NH's body

of existing abortion law.

Should NH pass stricter gun control laws?

We are fortunate to live in one of the safest states in the nation. New Hampshire is also a state with long established traditions of personal defense, hunting, and other shooting sports. Stricter laws would only infringe upon current law-abiding people and do little to restrain law-breakers. The laws on the books now are sufficient.

Should the New Hampshire government do more to address climate change?

We all should do more to address climate change. The state should encourage alternative energy production, conversion of fleet vehicles to electricity, bio-diesel, hydrogen fuel cells, reforestation wherever possible, and the underwriting of climate research at the state's colleges and universities. The state should do more to attract and recruit private enterprises that work the fields just mentioned. We should also strive to strengthen regional partnerships with the rest of New England and Quebec in any promising climate initiatives. The state must also hold our Federal representatives to account for their part in seeking national and international solutions to climate issues.

Cyril Aures, NH House of Representatives Candidate, Republican

Do you support the state's current system of public school funding, with each district's total funding primarily dependent on local property tax revenue?

Creating new taxes, or raising taxes, will not fix the funding problems within the public school system. Funding public-schools while providing property tax relief to homeowners is a necessity. Why should only the wealthy, like my opponent, have access to choices of schools or funding for their children. The above mentioned options will enhance competition for all students giving them more opportunities to meet their specific educational needs. These needs are best determined by the student along with their Parents guidance and support. I will work to pass Parental Rights legislation and funding which is necessary to give our families more opportunities.

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)?

Rosemary and I have tried to adopt children but were denied, once by parents that allowed their 16 yr old daughter to abort a beautiful healthy baby that we were willing to raise with no assistance from the family. Do you support the state's current system of public-school funding, with each district's total funding primarily dependent on local property tax revenue?

According to the 1977 Claremont (and Pittsfield!) Lawsuit, state property taxes for education must be "administered in a manner that is equal in valuation and uniform rate throughout the state." There is great disparity between the tax bases of different towns. The school funding system continues to be broken. We need to work together across political party lines to come up with a solution which does not penalize towns (and more importantly our students!) with higher property taxes. This issue has gone on too long and needs to be resolved.

Do you support the "Education Freedom Account" program, which gives students access to the per-pupil share of state school funding to spend on private school or home school expenses?

I believe there is merit in the concept of providing options for students but we need to do that within the context of public schools. I cannot support a program that is un-funded, takes away money from public schools and ultimately puts the burden back on the homeowner via property taxes.

90% of those who received these vouchers were already attending either a private school or being home schooled. The vouchers did not change behaviors of students in the public schools. Recipients were rewarded financially to the financial detriment of the taxpayers. The program was budgeted for \$185,000 in the first year and its costs now exceed \$10 million (and growing!), which will ultimately affect our towns and our pocketbooks.

I look forward to working together with other creative minds to find a solution that helps students who are truly in need, while not impacting either our towns or students.

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)

I was in college before Roe vs. Wade was passed. I am also a practicing Roman Catholic. Before Roe, friends who had money, traveled to England for abortions and later NYC; others took matters into their own hands. We cannot go back to those days. As a favorite Priest recently told me "We need to change hearts, not laws." I agree. Pregnancy is personal; when there are issues, they need to be addressed between a woman and her family and her medical team. NH should not ban abortions during the second trimester.

Should NH pass stricter gun control laws?

Yes. We need to provide a safe environment for our community and most importantly our children. I believe the first step in terms of legislation could be the pro active approach that has been passed in many states including FL - a Red Flag Law. This is an innovative approach where medical and sometimes school professionals can put a temporary restriction for purchasing a gun for anywhere between two weeks and a year. This is a sensible bi partisan approach that passed this year in the NH Legislature but unfortunately was vetoed by Gov. Sununu.

After we pass the Red Flag legislation, I would like to next look at guns being allowed on school property, which is currently legal in our state. This would be the second sensible gun legislation I would like to pursue for the safety of our community.

Should New Hampshire government do more to address climate change?

We need to focus on ways of diversifying our energy resources away from our current dependency on fossil fuels. It is a common belief that this is one of the reasons why our state leads New England in utility rate hikes because of the lack of innovation in terms of alternate energy resources.

Climate change does affect all of us in NH, USA and the world. Our NH economy has a large dependency on

tourism and even slight changes in climate can affect our ski industry, our fall foliage visitors and (even though our coastline is the smallest in the US!) our beaches!



I understand the Republicans supported taking 100 million dollars from 363 million dollars in the amount to be raised by the state education tax for the 2022-2023 school year. Do you support the "Education Freedom Account" program, which gives students access to the per-pupil share of state school funding to spend on private school or home school expenses?

I favor the EFA program, and so do many parents in town. I found that participation in the EFA program has been higher than expected. The opponents believe that this is draining much-needed dollars from the schools. Unfortunately, many parents have given up on the state school system and have sent their children to schools

of their choice for years. Now they are just getting long overdue help. Homeschooling is not easy for parents, and most can't afford private schooling even with help. The amount of financial assistance is much less (1/4) of what is needed to support a student in a traditional school. State schools are the first choice for most families, and providing competition will only help make them the best option. If we improve the schools, they will come!

Should New Hampshire ban abortions during the second trimester (e.g. after 15 weeks gestation)?

I am pro-life and believe that every pregnancy and birth is extraordinary. The Democrats want women's choice above all else, forcing abortion to be the term of life. This position makes no sense. There has to be a balance between the woman's choice and the fetal life. I will support the Fetal Life Protection Act, and there will always be provisions for the mother's health needs. Selectboard Review - October 25, 2022

The tax rate for 2022 is lower than last year at \$23.78, and we didn't have to touch the fund balance to lower it! We couldn't have done it without some good old Yankee thriftiness by all our departments.

The Select and Planning Boards have been put on the spot by a legal challenge to a Planning Board decision denying site plan approval for a communications tower behind Maxfield's Hardware on Upper City Rd. The denial was in response to opposition by residents who will be affected by the 150' tower. That decision has been challenged by the developer, Vertex, and without reconsideration by the Planning Board, we'll end up in court. The issue is that the Zoning Ordinance section that deals with towers allows for them in the Lt. Industrial/Commercial district. We're not sure how long the zoning ordinance has allowed, them but it's beyond the memory of any present board members. Legally, we have to come up with a plan that will let the tower be approved. Neither board is afraid to take on a fight; we stand a good chance of winning, but town counsel tells us this would not be it. Vertex has agreed to erect a single pole tower rather than a lattice tower, but that's their only real concession. When it came to our vote, we all recognized the expense and futility of ignoring the writing on the wall, held our noses, and voted yes under duress. Ultimately, the Planning Board must also vote, but this shows them the Select Board's position on spending money in court for a case we have no real chance to win.

The original denial was intended to send a message, hoping they'd take the hint. They didn't. We did what we could. Carl Anderson








