Select Board Review--April 23, 2024

A Watson St. resident contacted the Board regarding the possibility of lowering the speed limit on their street. This particular street is narrower than most, as well as congested, and the Board indicated it would consider the request after an upcoming (date tbd) public hearing for several changes to the traffic ordinance.

Officer Hazel of the Police Dept. submitted his resignation, with regret, due to his inability to find suitable rental housing in or near Pittsfield in almost a year since his rehiring. Hazel was an asset to the Dept. and we hate to lose him.

Chris Hill was reappointed to the Conservation Commission. Lois Giegerich and David Stasiak were reappointed to Parks and Recreation. Thanks to all of them for continuing to step up for these volunteer positions. We'd like to see some new blood help out as well, so how about it, people?

Pittsfield Historical Society and Boy Scouts of America were granted charitable exemption status for their properties. Two Veteran's tax credits were approved. One elderly exemption was denied due to a disqualifying amount of total assets. Three solar energy systems were granted tax exemptions for that part of their assessments. A \$5,200 current use land change tax was assessed.

The Fire Dept. requested Support Company volunteer Garret Mullen be transitioned to paid call member. Several inactive Support Company volunteers were terminated and equipment that was issued will be returned to the Dept. Firefighter/AEMT Dylan Sargent's performance review and grade step increase were approved by the Board.

Pittsfield presently has just one tax payment plan in place, which is current. The plan was extended because the taxpayer is making good on our agreement.

The Board was informed that due to the Pittsfield Legion Post Commander's illness, there was insufficient manpower to conduct the Memorial Day Remembrance Ceremony this year by that group and therefore would be cancelled. The Board of Selectmen unanimously found this to be unacceptable and consequently we'll see that this very important observance continues this year. Selectman Jim Allard volunteered to organize the details, and Selectwoman Carole Richardson offered to coordinate those needs with Jim. The Board as a whole will see that the ceremony goes on proudly and uninterrupted, and we invite and strongly encourage the residents of Pittsfield to join us at Dustin Park on Main St. at 1 PM, May 26th to remember and honor all those who gave their lives so that we remain free. Carving out a few minutes of one day certainly seems like the least we can all do, considering their sacrifice to the country. *Carl Anderson*

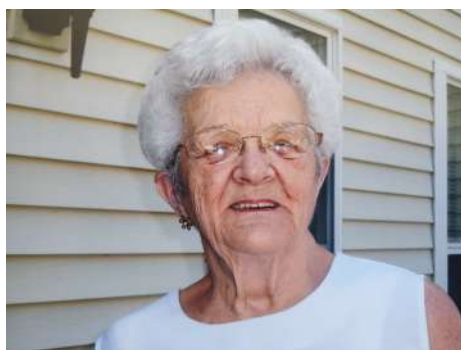

Cook's Corner Strawberry Strudels

This is my favorite time of year! The beautiful berries and fruits are starting to show up at the market.

This recipe is fun to make, and quite

versatile. We use strawberry preserves here, but you can easily substitute blueberry preserves (top with fresh blueberries); or raspberry jam (with fresh raspberries); or even apricot preserves, which I love and when I make these with apricot preserves, I typically top the strudels with fresh cut peaches. Yum-O! These are kind of like homemade "Pop Tarts," only much better and healthier. They are a delightful dessert, but also great for breakfast or brunch. Bon appetit!

MP Christakos

1 (17.3 oz) package frozen puff pastry sheets, thawed

½ cup strawberry preserves

2 tsp cornstarch

¾ tsp grated lemon zest (1 lemon)

1 large egg

¼ cup plus 1 TBSP heavy whipping cream, divided

1 cup powdered sugar, sifted

¼ tsp vanilla extract

1/8 tsp kosher or coarse salt

Heat oven to 400. Unroll 1 puff pastry sheet on a clean work surface; cut into 6 rectangles. Place on a parchment lined, large, rimmed baking sheet, at least ½ inch apart. Repeat process with a second piece of puff pastry sheet; set aside.

In a small bowl, stir together preserves, cornstarch and lemon zest. Place a heaping TBSP of the preserves mixture in the center of each pastry rectangle, leaving a ½ inch border around the edges. Whisk together egg and 1 TBSP of the cream in a small bowl. Lightly brush the pastry edges of the reserved top rectangles with the egg mixture.

Prick the reserved pastry rectangles all over with a fork, then place them on top of the preserve-covered rectangles, pressing to seal the edges. Crimp the edges with a fork. Brush the tops of the strudels with the remaining egg mixture. Bake in the oven until golden brown, about 18-20 minutes, rotating the pan half way through the bake time. Remove from the oven. While the strudels are still warm, flatten them slightly. Whisk together powdered sugar, vanilla extract, salt and remaining ¼ cup of cream until smooth. Drizzle evenly over the tops of the strudel, in a diagonal pattern. Top with fresh, sliced strawberries to serve.

May 2 was our first session during “Crossover,” when the House votes on the approved Senate Bills. Fifty-five bills went through consent, and 39 made it to the floor for amendments or discussions. The Senate had a great day, with over 80% getting approval.

Floor bills that were discussed on May 2: **SB359**, which raised the minimum age for marriage from 16 to 18, was passed after two failed amendments; 192-174. Cyril and I supported this bill if emancipated 16-year-olds were exempt.

SB417 related to out-of-home placements for children to improve safety, and preference based on placement with siblings and proximity to the child’s community, passed; 191-174.

SB376 established a mandatory minimum 5-year sentence for transporting into NH with the intent to distribute fentanyl class drugs, failed; 229-137. Most representatives felt that more needed to be done!

SB414 established a mandatory minimum sentence for the distribution of controlled drugs with death to 10 years, which was tabled; 340-24. This law definitely needs more work, and the vote agreed!

SB563 prohibited state and local government entities from adopting sanctuary policies to prohibit or impede the enforcement of the federal immigration law, and was tabled; 188-177.

SB219 required school districts to post mandatory reports of school expenses, including average cost per pupil, average teacher salaries, and top administrator salaries, which failed; 178-172. The mandatory report filing is very confusing. To their credit, the Pittsfield School Board has requested a very standard breakdown from the superintendent that lists complete salaries for all school personnel.

SB341 required mandatory disclosure by school district employees to parents, failed; 182-179.

SB380 moved the state primary date from September to June, failed; 190-176.

SB403 addressed the healthcare workforce in order to improve communication and make directives more accommodating for employees, passed; 188-178. This was an attempt to make these jobs more appealing to the workforce.

SB496, which directed the Department of Health and Human Services to establish a climate and health protection program, passed; 186-182.

SB538 established a tax relief program for office conversion to residences, and provided changes to local government to adopt zoning changes related to parking requirements and lot size to sewer infrastructure, failed; 188-173. Cyril and I agreed that this bill just went too far, interfering with local land control!

And our favorite! **SB603** provided funds to speed up the release of unused 603 exchange phone numbers by adding \$100,000/yr to the effort already in progress. “603” is an amazing brand that NH needs to preserve for as long as possible. Opponents say that we are only putting off the inevitable. We agree, but we feel that it is worth it to keep the brand. A seven-digit number not leading with a 1 or 0 will give you 8,000,000 possibilities. With a population of 1,400,000, you do the math! The legislature did and passed the bill, 257-120.
