The Pride of a Woodworker

Why bother writing about a list of objects crafted by students in 1921? Because the Pittsfield Schools weren't doing particularly well in most areas of concern. That's why I'm going to talk about a dedicated teacher who was willing to inspire so many others!

Howell Potter was the manual arts teacher for 98 students in the grammar and high schools. He taught both blacksmithing and woodworking, but we'll focus on the latter.

The following projects were made in the woodworking department: 4 library tables, 1 cabinet table for public library, 5 smoking cabinets, 1 umbrella



stand, 3 hall trees, 1 taboret, 4 match holders, 3 checker boards, 3 oak sewing cabinets, 2 box traps, 2 card index cabinets, 1 rabbit trap, 5 bread boards, 14 cake and meat boards, 6 letter holders, 25 pin trays, 9 knife boxes, 2 milking stools, 22 coat hangers, 1 weather vane, 26 hammer handles, 7 clothes hangers, 2 dibbles, 15 broom handles, 2 foot rests, and 6 medicine cabinets.

Students were also instrumental in making many repairs to chairs, desks, and other fixtures for the grade and high schools.

Potter commented in the January 31, 1922 annual report, "You will see work that is modern in conception, educating in psychological sequence, economic in proportion to its intrinsic and commercial value, and practical in its applications to daily life."

My father-in-law, Clifton S. Cram, was a student that year. It's highly probable he crafted his oak library table as his project.

For a short time, Clifton taught manual arts in PA. He soon returned to Pittsfield for other pursuits, but utilized his skills for years at home and at the family cottage.

The biggest worry was the rickety old ladders that he used on structural projects. So for me, "He was shaky on a ladder, but masterful with a piece of wood."

Perhaps Potter instilled a sense of pride for a job well-done. I'd certainly like to think so, anyway. *Jean Cram*

Cook's Corner Chicken Parmesan Meatballs

Here's a favorite from our kitchen that I hope you will also enjoy. The list of ingredients looks a little long-ish, but I promise, these meatballs are super easy to make. We typically serve these over cooked farfalle pasta (bow tie shape) or penne. Throw a nice salad alongside and crusty rolls to soak up the yummy sauce. These also freeze well. If you plan to freeze them, omit the shredded Mozzarella when baking. Save the Mozzarella and the Panko crumb topping for when you reheat. Mangia, my friends!

5 TBSP olive oil, divided

5 cloves garlic, sliced thin

1 (28 oz) can crushed tomatoes

1 (15 oz) can tomato sauce

2 & ¼ tsp dried oregano, divided

1 & 1/2 tsp salt, divided

¼ tsp red pepper flakes

25 Ritz crackers, crushed (about 1 cup when crushed)

2 & ½ cups grated Parmesan cheese, divided

1 large egg, lightly beaten

2 tsp garlic powder

1 tsp black pepper

2 lbs ground chicken

2 cups shredded Mozzarella cheese

1 cup Panko breadcrumbs

14 cup torn or roughly chopped fresh basil

Heat 3 Tbsp olive oil in a large skillet over medium high heat. Add sliced garlic and cook until lightly browned, about 1 minute. Stir in crushed tomatoes, tomato sauce, ¼ tsp oregano, ¼ tsp salt and the red pepper flakes. Bring to a simmer, reduce heat to medium low and cook until slightly thickened, about 10 to 15 minutes. Stir from time to time. Remove from heat, cover and keep warm.

Heat oven to 350. Adjust rack to the middle position.

In a large bowl, combine cracker crumbs, 2 cups of Parmesan cheese, beaten egg, garlic powder, black pepper, remaining 2 tsp oregano and 1 tsp salt. Add the ground chicken and mix with your hands until well combined. Divide the mixture into 20 portions (about $\frac{1}{4}$ cup per meatball) and transfer to a lightly greased 9 x 13 baking dish.

Pour the sauce over the meatballs, then sprinkle the Mozzarella on top. Bake until meatballs register 160 degrees and the cheese is melted and beginning to brown, about 40 to 45 minutes. Let cool for 15 minutes.

Meanwhile, combine Panko, remaining 2 Tbsp of oil and remaining salt in a bowl. Microwave until the Panko is golden brown, 1 to 3 minutes, stirring every 30 seconds. (Or you could toast the Panko mixture in a small skillet).

Sprinkle the meatballs with the Panko mixture add remaining ½ cup Parmesan cheese and top with the fresh chopped basil.

School Board Update

The School Board meeting on February 3rd had a full

agenda. In addition to his report and data surrounding discipline, PES Principal Mike Wiley told the board about the PTO sponsored literacy night that is coming up Wednesday, February 23, from 5:30-7:30 at PES. PMHS Principal Derek Hamilton shared highlights from student work during the Winter Showcase surrounding Learning Studios from the first semester. Superintendent Bryan Lane updated the board on Covid related protocols and his proposal for a new teacher evaluation system. Additionally, he shared the information from Team Design Herriman about a feasibility study to determine costs for retrofitting PMHS if PES were to be moved into the building. The board voted to move forward with this study to ensure that the community had all of the information regarding costs if there were to be a tuitioning agreement for high school students in the future. 

Selectboard Review February 8, 2022

The "deliberative session" of Town Meeting was held last Saturday to just a small (count them on your fingers) group of taxpayers, with just two questions asked regarding the Warrant Articles- and no amendments to any Article. The budget process started last summer with members of the Capital Improvement Plan meeting multiple times over the course of months, interviewing department heads, reviewing upcoming town needs for the next 10 years, and coming up with a plan to put away money for these needs to minimize radical tax impact in any given year. That recommendation went to the Board of Selectmen who then spent weeks laboring over the proposed budget, again interviewing department heads, balancing the needs with what taxpayers could be asked to pay. The Selectboard's budget then went to the Budget Committee which spent more grueling weeks scrutinizing every penny that will ultimately be asked for in the warrant. Under the old town meeting process, these items were discussed, information shared and then voted on right then. Maybe 150 people would show up and make the decisions for the entire town. Under SB2, the voting takes place at the ballot box by a more substantial number of voters. That would be ok, except that almost none of those voters have actually heard any reasons for or against the articles, and most have no first-hand knowledge of any of it. Months and months of intense financial scrutiny trying to balance wants and needs with sound judgment can be undone at the ballot box. When you vote, hopefully you'll keep in mind that the CIP, the Selectboard, and the Budget Committee are all taxpayers themselves and have all done their level best to keep Pittsfield an affordable place to live while still keeping the town operating properly. To my constituents in Pittsfield,

This week, the House continued with committee work. My committee voted out eighteen bills, including two we heard this week: we rejected HB 1321, repealing all the changes we had made to the governor's emergency powers in the last year, including the sponsor's HB 1037; and HB 1545, requiring a film database, since the sponsor found Travel & Tourism already uses one!

HB 1535, which granted a cost of living increase to people retired at least 5 years, was amended and recommended to pass. The amendment left the current year increase, but deleted the retirement system's mandate to give future increases based on Social Security's increases. That was estimated to have about a \$2 billion dollar cost increase, and the vast majority of that would be paid through our local property taxes. It also required that the initial increase be funded from this year's surplus, so there would be no property tax impact at all.

We sent several bills to interim study, seeing merit in the idea but not agreeing on the details: my HB 1191, allowing homeowners to work on duplexes as well as single family homes; HB 1429, licensing massage establishments; HB 1444, registering medical spas; and HB 1566, on the prescription drug affordability board. These bills would have gone to a second committee, so we'd run out of time to work on them now.
